26 May 1853 To Henry Rodd, Campbell St, Hobart.4

17 October 1853 Married as 25y, spinster, to William Benson, 35y, carpenter, at St George's CE

Church, Battery Point; witnesses Stuart Park & Jane Park.8

31 March 1865	To Cascades Gaol. <sup>4</sup>
4 April 1865	Tried at Hobart SC with Margaret Sutterley & Jane Omant charged with stealing money from the person; acquitted. $^{4,13}$
25 April 1866	Tried at Green Ponds PC charged with having on 16 April at Kempton insulted Catherine Poole, a passer-by; witnesses Catherine Poole & Jane Omant; fined 10s & costs, totalling £1.3.6. $^{14}$
2 June 1866	Son James Emmett, 9y, with Edward Omant, 4y, Henry Omant, 4y, Edward Oliver, 8y & Alfred Oliver, 5y, brought up from 26 May on remand for appearance of informant or defendant, charged with cruelty to a calf, property of Thomas Wright, schoolmaster; remanded to 3 June 1866; reprimanded & discharged. <sup>15</sup>
4 July 1866	Tried at Green Ponds PC with Bridget Eldridge ( <i>Maria</i> ), brought up from 29 June & 3 July on remand for attendance of a 2 <sup>nd</sup> magistrate, charged with larceny under £5 in having on 27 June at <i>Veterans Inn</i> , Kempton, feloniously stolen a £1 bank note, value 20s, silver coins, value 5s, & 1 box, value 3p, property of Anastasia McCarthy of Kempton; sentence 12m HL, Cascades Gaol (discharged w/e 23 May 1867). <sup>16</sup>
7 July 1866	Arrived at Glenorchy PO under police escort from Kempton on way to Cascades Gaol. 18

27 February 1875	Arrived at Pontville PO from Green Ponds under police escort to Hobart. <sup>20</sup>
1 June 1877	Tried at Green Ponds PC charged with larceny under £10 in having on 29 May at Kempton feloniously stolen 12 mangel-wurzels, value 1s, property of Daniel Brown snr, Kempton; sentence 6m HL, Campbell St Gaol (admitted from Green Ponds PO 9 June; discharged 30 November). <sup>24</sup>
5 June 1877	Arrived at Pontville PO from Green Ponds under police escort. <sup>20</sup>
9 June 1877	Arrived at Glenorchy PO under police escort from Kempton on way to Campbell St Gaol. <sup>21</sup>
8 February 1879	Tried at Green Ponds for larceny; sentence 12m HL, Campbell St Gaol (admitted from Green Ponds PO 13 February; discharged 26 January 1880, residue of sentence remitted). <sup>21,25</sup>
