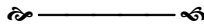

19 April 1849	Received at Grangegorman Depot, Dublin at 9:30am. <sup>2</sup>
16 March 1852	Ticket-of-Leave granted. <sup>3</sup>
17 August 1852	Recommended for Conditional Pardon. <sup>3</sup>
8 February 1853	Application for permission to marry Robert Drew ( <i>Hyderabad</i> 3); will be recommended if the clergyman is satisfied. <sup>4</sup>
1 June 1853	Ticket-of-Leave revoked, to be detained in separate treatment at Cascades FF. <sup>3</sup>
13 June 1853	Ticket-of-Leave revoked for misconduct. <sup>5</sup>
25 June 1853	Application for permission to marry Robert Drew ( <i>Hyderabad</i> 3); referred 25 June to Superintendent FF as to woman's conduct (refused 6 July). <sup>4</sup>
27 September 1853	To be released from separate treatment & conduct to be reported in 1 month. <sup>3</sup>
1 November 1853	May enter private service, but not in the district of Hobart nor in the same district as Ellen Pierce ( <i>qv</i> ) by the same ship. <sup>3</sup>
3 November 1853	To F Wilcox, Clarence Plains. <sup>3</sup>
7 March 1854	Ticket-of-Leave restored. <sup>3</sup>
18 April 1854	Conditional Pardon approved (issued at Hobart 19 April). <sup>6</sup>
26 March 1856	Free by servitude.
