<i>Gaol Report</i> quiet	<i>Surgeon's Report</i> quiet
<i>Station of Gang</i> Anson	<i>Class</i> 3 rd from 22 March 1850
<i>Religion</i> not stated	<i>Literacy</i> neither read nor write
<i>Marital Status</i> widow	<i>Trade</i> housemaid, servant
<i>Age</i> 47 ^c	<i>Native Place</i> Co. Galway
<i>Height</i> 5' ¼", 5'	<i>Complexion</i> fair, pale
<i>Head</i> round	<i>Hair</i> grey
<i>Visage</i> round	<i>Forehead</i> high
<i>Eyebrows</i> dark	<i>Eyes</i> blue
<i>Nose</i> medium	<i>Mouth</i> large
<i>Chin</i> short	<i>Marks</i> none
<i>Family</i> daughters Winny, Mary (both transported on the <i>Lord Auckland</i> 3) & Ellen (5y, ^d on board); sister Mary	
10 April 1848	Daughters Winny & Mary Loughlan tried at Co. Galway charged with killing a sheep; sentence 10y transportation each. ²
20 January 1849	Daughters Winny & Mary Loughlan arrived in VDL, prisoners on the <i>Lord Auckland</i> 3. ²
24 May 1849	Received at Grangegorman Depot, Dublin at 10:30am with daughter Ellen Loughlan, 3y. ³
12 April 1850	Died at New Norfolk, accidentally drowned in Derwent River, 48y, PPH. ⁴
13 April 1850	Inquest into death held at house of William Dean, Belmont; verdict accidentally drowned. ⁵
8 August 1850	Daughter Ellen Loughlan, 7y 2m, admitted to Female School, Queen's Orphanage, New Town. ⁶

^b Offence given as killing a sheep on gaol report and Grangegorman prison register; Ellen may have been arraigned on this charge as well.

^c Age given as: 34y on description list; 40y on Grangegorman prison register.
