c1821 **Born** at Winsley, near Bath, Wiltshire, England; father Robert Maltman; mother Mary.<sup>2</sup>

17 June 1821 Baptised at Winsley, Wiltshire, England; father Robert Maltman, weaver; mother Mary.<sup>3</sup>

1823 Brother Daniel Maltman born at Winsley, Wiltshire, England; father Robert Maltman; mother Mary.<sup>4</sup>

13 July 1823 Brother Daniel Maltman baptised at Winsley, Wiltshire, England; father Robert Maltman, weaver; mother Mary.<sup>4</sup>

15 August 1840 Tried at the Assizes, Devizes, Wiltshire, England indicted for larceny in stealing wearing apparel from a dwelling house; sentence 7 years transportation.<sup>5</sup>

5 April 1841 Departed Woolwich, England on the *Rajah*.<sup>6</sup>

19 July 1841 Arrived at Hobart on the *Rajah*.<sup>6</sup>

c24 July 1841 Upon arrival at Hobart, assigned to Dr Dermer, Hobart.<sup>7</sup>

21 December 1841 At Richmond.<sup>5</sup>

31 December 1841 Mustered in the service of Mr J Lewis, Richmond.<sup>8</sup>

8 June 1842 Application for permission to marry Robert Ribbond<sup>9</sup> (*Mary III*) sent to the Muster Master.<sup>10</sup>

24 June 1842 Application for permission to marry Robert Ribbond sent to the Secretary; approved.<sup>10</sup>

cJune 1842	<b>Married</b> Robert Ribbond at Richmond; Sarah aged 18; Robert aged 32. <sup>11</sup>
24 April 1843	<b>Daughter</b> Elizabeth Ribbond born at Richmond; father Robert Ribbon, labourer; mother Sarah Ribbon. <sup>12</sup>
30 April 1843	Daughter Elizabeth Ribbond baptised at St Luke's Anglican Church, Richmond; parents residents of Richmond. <sup>13</sup>
22 May 1844	<b>Son</b> Thomas Ribbond born at Richmond; father Robert Ribbond, illiterate, farmer; mother Sarah Mortman. <sup>14</sup>
21 February 1845	Ticket of Leave granted; gazetted 25 February. <sup>15</sup>
4 March 1845	Son Thomas Ribbond died of dysentery at Richmond; aged 9 months, father Robert Ribbond, labourer; informant Moses Parker, resident of Richmond. <sup>16</sup>
6 March 1845	Daughter Elizabeth Ribbond died of dysentery; aged 2, father Robert Rebond, labourer; informant Moses Parker, resident of Richmond. <sup>17</sup>
1 September 1845	<b>Son</b> Robert Ribbond born in the Hobart district; mother Sarah Maltman; no informant given. <sup>18</sup>
15 August 1847	Free by servitude; Certificate of Freedom available for collection; gazetted 3 August. <sup>19</sup>
29 September 1847	<b>Son</b> Thomas Ribbond born at Kangaroo Point Road, Richmond district; mother Sarah Maltman; informant father Robert Ribbond, illiterate, farmer. <sup>20</sup>
19 April 1848	Son Thomas Ribbond died of dysentery at Kangaroo Point Road, Richmond district; aged 6½ months; informant father Robert Ribbond, farmer, illiterate. <sup>21</sup>
2 April 1849	<b>Daughter</b> Ellen Ribbond born at Coal River Road, Richmond; mother Sarah Maltman; informant father Robert Ribbond, illiterate, farmer. <sup>22</sup>
1851	Daughter Ellen Ribbond died at Melbourne, VIC; aged 1. <sup>23</sup>
c1853	Son Thomas B Ribbond born in Victoria. <sup>24</sup>
1872	Son Robert Ribbond married Mary Ann Mason in Victoria; Robert born Richmond, TAS; Mary Ann born Geelong, VIC. <sup>25</sup>
1874	Grandson Robert Bond born at Dunolly, VIC; father Robert Bond; mother Mary Ann Mason. <sup>26</sup>
1876	Grandson Walter Thomas Bond born at Dunolly, VIC; father Robert Bond; mother Mary Ann Mason. <sup>27</sup>

- 1884 Granddaughter Minnie C Bond born at Sydney, NSW; father Robert Bond; mother Mary A Bond.<sup>30</sup>
- 20 November 1885 Husband Robert Ribbond died of old age and retention of urine at Dunolly Hospital, VIC; aged 75, gardener; born Norfolk, England; father Thomas Bond, labourer; mother Elizabeth Emmerson; 22 years in Tasmania, 34 years in Victoria; children: Thomas, deceased; Elizabeth, deceased; Robert, aged 40; Ellen, deceased; Thomas, aged 34; informant wardsman, Dunolly Hospital.<sup>31</sup>
- 21 November 1885 Husband Robert Ribbond buried at the General Cemetery, Dunolly, VIC.<sup>32</sup>
- 1887 Grandson George W Bond born at Sydney, NSW; father Robert Bond; mother Mary Bond.<sup>33</sup>
- 1889 Granddaughter Agnes B Bond born at Sydney, NSW; father Robert Bond; mother Mary A Bond.<sup>34</sup>
- 19 August 1893 Grandson Edward Earnest Bond born at 4 Globe Street, The Rocks, Sydney, NSW; father Robert Bond; mother Mary A Bond.<sup>35</sup>
- 26 March 1895 Son Robert Ribbond died at 4 Globe Street, The Rocks, Sydney, NSW; father Robert Bond; mother Sarah A Bond.<sup>36</sup>
- 5 March 1900 **Died** of general paralysis and coma at 4 Globe Street, The Rocks, Sydney, NSW; aged 75, born Bath, England, father Maltman; 49 years in New South Wales; children living Thomas B aged 49, children deceased 3 males 2 females; informant daughter-in-law Mary Ann Bond, resident of 4 Globe Street.<sup>37</sup>
- 7 March 1900 **Buried** at the General Cemetery, Waverley, NSW.<sup>38</sup>  
Funeral notice:  
*BOND. – The Friends of SARAH ANN BOND are respectfully invited to attend her Funeral, which will leave her late residence, 4 Globe-street, Sydney, TOMORROW, March 7<sup>th</sup>, at 8.30 a.m., for Waverley Cemetery.*<sup>39</sup>
