MARY RICHARDSON (18), pleaded guilty to a charge of having at New Lambton, on the 14th of August last, feloniously stolen two cotton gowns, and various other articles, the

property of Elizabeth Summerson.6

19 July 1841 Arrived at Hobart on the Rajah.7

c24 July 1841 Upon arrival at Hobart, assigned to Captain Read, New Town.8

11 September 1841 Received at Cascades Female Factory, Hobart.9

12 September 1841 Admitted to the hospital at Cascades Female Factory, Hobart.9

Died of fever at Cascades Female Factory, Hobart Hospital, Hobart; aged 19.10 5 November 1841 6 November 1841 Inquest held at 10 am at Cascades Female Factory, Hobart before William Thomas

Napier Champ Esquire, coroner.

Verdict: died by the visitation of God in a natural way, to wit by fever.9

Statement of witness and shipmate Margaret Shaw (qv):

The information on oath of Margaret Shaw saith I am a prisoner of the crown and am nurse at the hospital of this establishment. I have seen the body on which this inquest is sitting it is that of Mary Richardson she was a prisoner she was admitted into the hospital on the evening of the 12th of September inst. She then complained of fever and cold she remained in the hospital until she died yesterday morning (5th Nov') about six o'clock. She was ill

during the whole time that she was in the hospital, she was attended during the time by Dr. Dermer who saw her once every day. She was nineteen years old. She received every attention that the hospital could afford. She was in assigned service and came into the factory only the day before she was admitted into the hospital.⁹

Statement of witness Dr William Dermer:

The information on oath of William Dermer saith I have seen the body of the deceased it is that of Mary Richardson. I have charge of the hospital of this establishment. On the 12th September last I admitted the deceased into the hospital, she complained of being exceedingly ill, which her appearance indicated she complained of extreme debility with pain in the right side. I prescribed the usual remedies which appeared to relieve her at the time. A few days after symptoms of fever showed themselves and in about three weeks she became convalescent & appeared to be doing well about a fortnight ago she had a relapse and in spite of every thing I could do and of every medical aid, she gradually got worse and yesterday morning about six o'clock she died the cause of her death was fever. I saw her every day during her illness as far as I know she received every possible attention from the nurses and I believe my orders respecting her were strictly obeyed. If she had been in any way neglected I should have heard of it. I never heard her complain of her illness being caused by any illtreatments.
